## RESOLUTION NO. 854

**A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21, AUTHORIZING THE COLLECTION OF REGULAR PROPERTY TAX IN THE 2016 TAX YEAR.**

**WHEREAS:** The Board of Fire Commissioners for Pierce County Fire Protection District No. 21 has met and considered its budget for the calendar year 2016; and,

**WHEREAS:** The District's actual levy amount from the previous year was \$7,647,174.01; and,

**WHEREAS:** The difference between the previous year's actual levy amount and the I-747 1% limitation amount must be stated and requested below only in order to establish a threshold for future limitations. The allowable levy amount under that 1% limitation for the highest regular tax since 1985 is \$8,710,070.99; and

**WHEREAS:** The Board of Fire Commissioners hereby authorizes the collection of a Maintenance and Operation levy in the amount of \$2,750,000.00, as approved by the voters on November 4<sup>th</sup>, 2014; and


**WHEREAS:** The population of this District is more than 10,000.

**THEREFORE, BE IT RESOLVED BY THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21 THAT:**

Section 1. An increase in regular property tax levy is hereby authorized for the levy to be collected in the 2016 tax year.

Section 2. The dollar amount of the increase over the actual amount from the previous year shall be \$1,149,997.69 which is a percentage increase of 15.0382% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.


