## RESOLUTION NO. 856

**A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21 RESCINDING CERTAIN OPERATING INSTRUCTION POLICIES OF PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21.**

**WHEREAS:** A recent review of certain operating instruction policies (hereafter known as "policies") was conducted to determine if these policies are still pertinent to the operations of the Fire District; and

**WHEREAS:** Staff has agreed that the specific policies reviewed are no longer viable, needed or are outdated and wish to bring forward to the Board of Fire Commissioners a recommendation to rescind these policies; and


**WHEREAS:** The Board of Fire Commissioner has the authority to rescind policies of the District they determine are no longer viable, needed or are outdated.




Section 1. The following policies of Graham Fire & Rescue be rescinded as of today for the reasons listed:

- a. **OI 325 – Restocking Ambulances (2000)**. OI 323 covers restocking apparatus and fire station aid kits. (Outdated, not needed)
- b. **OI 326 – Return From Use For Travel Trailer (2000)**. The District no longer owns a travel trailer. (Outdated and not needed)
- c. **OI 407 – Predesignated Landing Sites (2000)**. GPS technology has developed to the point that predesignated landing zones are unnecessary. (Outdated, not needed)


