A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21 AUTHORIZING THE COLLECTION OF EMS PROPERTY TAX IN THE 2020 TAX YEAR.

WHEREAS: The Board of Fire Commissioners for Pierce County Fire Protection District No. 21 has met and considered its budget for the calendar year 2020; and,

WHEREAS: The District's actual levy amount from the previous year was \$3,148,093.20; and,

WHEREAS: The population of this District is more than 10,000.




Section 1. An increase in EMS property tax levy is hereby authorized for the levy to be collected in the 2020 tax year.

Section 2. Property tax for Pierce County Fire District #21 EMS shall be levied at the rate of \$.50 per \$1,000 of assessed value as authorized by voter approval on November 5, 2019.




