RESOLUTION NO. 941 RCW 84.55.120

A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21, AUTHORIZING THE COLLECTION OF REGULAR PROPERTY TAX IN THE 2020 TAX YEAR.

WHEREAS: The Board of Fire Commissioners for Pierce County Fire Protection District No. 21 has met and considered its budget for the calendar year 2020; and,

WHEREAS: The District's actual regular property tax levy amount from the previous year was \$10,736,091.42; and,

WHEREAS: On February 13, 2018, the citizens of the District approved a four-year Maintenance and Operations levy not to exceed an annual amount of \$4,300,000.00; and

WHEREAS: The population of this District is more than 10,000.


THEREFORE, BE IT RESOLVED BY THE BOARD OF FIRE COMMISSIONERS FOR PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 21 THAT:


Section 1. An increase in regular property tax levy is hereby authorized for the levy to be collected in the 2020 tax year.


Section 2. The dollar amount of the regular property tax increase over the actual amount from the previous year shall be \$644,165.49 which is a percentage increase of 6.0% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.

Section 3. The Board of Fire Commissioners further authorizes the collection of a Maintenance and Operations levy in the amount of \$4,300,000.00.


