
Section 2. Candidates on this certified eligibility list must successfully complete further evaluation measures prior to receiving an offer of employment.

Section 3. This certified eligibility list shall be valid until December 31, 2016, unless the Board of Fire Commissioners chooses to extend or terminate the list.


